Payment Provisions:

- For Additional payments relating to pandemic requirements
- New VAT end user clause in respect of HMRC VAT reverse charge provisions

New clause relating to safeguarding.

Force Majeure now a circumstance for unpaid extensions of time.

Contract Details

- Numerous changes consequential on Contract Conditions and Preliminaries amendments.
- Provision for administration costs and liquidated damages for non-completion of Major Works added to LAD Appendix 1.
- Amendments to Appendix 7: Health and Safety Preconstruction Information – Introduction of additional items relating to pandemics and language generally tidied up across most items.

Preliminaries/ Service Specifications

- Clarification of some terminology e.g. Regulations to Regulatory Requirements in some context.
- Introduction of a Planned Completion Date for Major Works.
- Introduction of a Service Provider's Programme for undertaking/completing Major Works.
- Variations and extensions to Response Periods and Planned Completion Dates amended.
- Amendments relating to outdated gas check terminology (CP4, CP6 and CP12 are covered by LGSR).
